MORTGAGE

NOTICE TO BORROWER: THE NOTE SECURED BY THIS MORTGAGE CONTAINS PROVISIONS ALLOWING FOR CHANGES IN THE INTEREST RATE. INCREASES IN THE INTEREST RATE MAY RESULT IN HIGHER PAYMENTS. DECREASES IN THE INTEREST RATE MAY RESULT IN LOWER PAYMENTS.

THIS MORTGAGE made this 23rd day of October, 1986, between David D. Letizia and Marijo Letizia, his wife, of 457 Parkview, Elmhurst, Illinois, 60126 and Keith D. Meyer and Terri B. Meyer, his wife, of 9000 Lincolnwood Drive, Evanston, Illinois, 60203, (hereinafter

Mortgagor is indebted to Mortgagee in the principal sum of TWENTY-NINE THOUSAND SIX HUNDRED DOLLARS (\$29,600.00) which indebtedness is evidenced by Mortgagor's Note dated October 23, 1986, (herein referred to as the "Note"),

AND WHEREAS, the Note provides for interest to be charged on the balance of principal remaining from time to time outstanding at a rate equal to four percent (4.00%) above the weekly average yield, on United States Treasury of one year (hereinafter referred to as "Index"); and

WHEREAS, the initial interest rate charged under the Note for the first Twelve months is equal to nine and seventy-three one hundredths percent (9.73%), which rate is equal to four percent (4.00%) above the most recently available Index and the interest rate charged under the terms of the Note is adjusted at intervals of twelve months during the term hereof; and

TOGETHER with all the improvements now or hereafter erected on or attached to the property, and all easements, rights, appurtenances, rents, royalties, mineral, oil and gas rights and profits, water, water rights, and all fixtures now or hereafter attached to the property, all of which including replacements and additions thereto, shall be deemed to be and remain a part of the property covered by this Mortgage and all of the foregoing together with said property (or the leasehold estate if the Mortgage is on a leasehold) are herein referred to as the "Premises".

 - (b) Pay immediately when due and payable all general taxes, special taxes, special assessments, water charges, sewer service charges and other taxes and charges against the property, including those heretofore due, (the monthly payments provided in the Note in anticipation of such taxes and charges to be applied thereto provided said payments are actually made under the terms of said Note), and to furnish the Mortgagee, upon request, with the original and duplicate receipts therefore, and all such items extended against said property shall be conclusively deemed valid for the purpose of this requirement.

(f) Not suffer or permit any unlawful use of or any nuisance to exist on said Premises nor to diminish nor impair its value by any act or omission to act.
