THE SOUTH 79 FEET 7 AND 3/8 INCHES OF LOT 24 AND ALL OF LOT 25 IN BLOCK 1 IN CRANDALL'S FOREST GLEN SUBDIVISION OF THE EAST 1/2 OF THE SOUTH EAST 1/4 OF SECTION 9, TOWNSHIP 40 NORTH, RANGE 13 EAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS. PIN: 13-09-223-019 and 13-09-223-037

or its agents, due or to become due, or that may hereafter be contracted, and also to the payment of all expenses and the care and management of said premises, including taxes and assessments, and the interest on encumbrances, if any, which may be in its judgement deemed proper and advisable.

This instrument is given to secure payment of the principal sum and interest of or upon a certain loan for SEVENTY THOUSAND AND NO/100 dollars secured by a Mortgage or Trust Deed dated the 30th day of OCTOBER, 19 86, conveying and mortgaging the real estate and premises hereinabove described to GLADSTONE NORWOOD BANK and this instrument shall remain in full force and effect until said loan and the interest thereon and all other costs and charges which may have accrued under said Mortgage or Trust Deed have fully been paid.
