THE COVENANTS, CONDITIONS AND PROVISIONS REPERRED TO ON PAGE I (THE REVERSE SIDE OF THIS TRUST DEED):

A Mortgagors shall (1) promptly repair, restore or rebuild any buildings or improvements now or herdafter on the premises which may become damaged or be destroyed; (2) keep said premises in good condition and repair, without waste, and free from mechanic's or other liens or claims for then not expression subordinated to the lien hereof; (3) pay when due any indebtedness which may be secured by a lien or charge on the premises series or the lien hereof, and upon request exhibit satisfactory evidence of the discharge of such prior lien to Trustee or to holders of the socie; (4) complete within a reasonable time and building or buildings now or at any time in process of exection upon said premises; (5) comply with all requirements of law or municipal ordinances with respect to the premises and the use thereof; (6) make no material alterations in said premises except as required by law or municipal ordinances.

2. Mortgagors shall pay before any penalty attaches all general taxis, and shall pay special taxes, special pay in the premises when due, and shall, upon written request, furnish to Trustee or to holders of the note duplicate receipts therefor. Mortgagors shall keep all buildings and improvements now or hereafter situated on said premises insured against loss or damage by fire, lightning or windstorm under policies providing for payment by the insurance companies of moneys sufficient either to pay the cost of replacing or repairing the same or to pay in full the indebtedness secured hereby, all in companies assistance to the hoters of the note, under insurance policies payable, in case of iose or damage, to Trustee for the henefit of the holders of the note, such rights to be evidenced by the standard mortgage clause to be attached to each policy, and shall deliver all policies, including additional and renewal policies, to holders of the note, and in case of insurance about to expire, shall deliver renewal policies not less than ten days prior to the respective dates of expiration.

In case of default therein, Trustee or the holders of the note may, but need not, make any payment of perferm any act hereinbefore requised to Mortgagors in any form and manner deemed expedient, and may, but need not, make full or partial payments of principal or interest, on prior occurabrances, if any, and purchase, discharge, compromise or settle any tax lien or other prior lien or title or claim thereof, or riddent from any tax sale or floresture affecting said premises or contest any tax or assessment.
