

CONTRACT THAT NO LIEN OR CLAIM FOR LIEN MAY
BE FILED OR MAINTAINED

It is hereby stipulated and agreed by and between the undersigned Contractor and the undersigned Owner that pursuant hereto and pursuant to the provisions of a contract between the undersigned of even date herewith (herein called the "Contract"), no mechanic's lien or claim for mechanic's lien may be filed or maintained by anyone, including the Contractor, materialmen, subcontractors or sub-subcontractors, and the Contractor does hereby fully and completely waive and release for the undersigned Contractor, and for all subcontractors and their respective subcontractors, including materialmen, any and all claims of, or right to, mechanic's lien or liens, under the statutes of the State of Illinois, against, or with respect to, the Owner and the premises described as follows:

or any part thereof, or any improvement thereon, or with respect to the estate or interests of any person whatsoever in said premises or improvements, or any part thereof, or with respect to any material, fixtures, apparatus, or machinery, furnished or to be furnished to the said premises pursuant to said contract, or with respect to any moneys or other considerations which may be due at any time hereafter from the Owner to the Contractor, which claim of lien might be asserted by reason of the doing, making, or furnishing, heretofore or at any time hereafter, by the Contractor, materialmen, subcontractors or sub-subcontractors, of any labor, services, material, fixtures, apparatus, machinery, improvements, repairs or alterations in connection with the above-described premises or improvements thereon.

Contractor further agrees that upon the completion of the performance of said contract the above-described premises and all improvements thereon shall be free and clear of any mechanic's liens, not only of the Contractor but also of any and all of the subcontractors, materialmen, laborers, or sub-subcontractors who may furnish any labor, material, services, fixtures, apparatus, machinery, improvements, repairs, or alterations, in connection with or to the above-described premises relating to or as part of the improvements referred to in said contract, whether such liens relate to the above-described premises or any moneys or other considerations which may be due at any time hereafter from the Owner to the Contractor, or from the Owner or the Contractor to any

of the subcontractors, sub-subcontractors, or maintainmen.

The Contractor further agrees that the effect of this waiver shall not be impaired, affected or diminished by the provisions of said contract relating to production, from time to time, of written waivers of lien, nor by any other provisions apparently inconsistent with this waiver.
