AN ORDINANCE PROVIDING FOR THE ANNEXATION OF
CERTAIN REAL ESTATE TO THE VILLAGE OF ORLAND
PARK, COOK COUNTY, ILLINOIS (KOLDENHOVEN)

WHEREAS, there has been heretofore filed with the Village Clerk a Petition requesting annexation of the real estate hereinafter described to the Village of Orland Park, Cook County, Illinois; and

WHEREAS, said real estate is not now within the present corporate territorial limits of the Village of Orland Park, but is contiguous to and adjoining the present corporate territorial limits of the Village of Orland Park; and

WHEREAS, said real estate is not now within the present corporate territorial limits of any city, village, or town; and

WHEREAS, there are no electors residing on said real estate; and

WHEREAS, it is to the best interests of the Village of Orland Park that said real estate be annexed to the Village of Orland Park in accordance with the provisions of the Statutes of Illinois in such case made and provided.

NOW, THEREFORE, BE IT ORDAINED, by the President and Board of Trustees of the Village of Orland Park, Cook County, Illinois, as follows:

SECTION 1

That the following described real estate, to-wit:

Lot 10 in Ideal Acres, being a Subdivision of the West 20 acres of the East 22 acres of the Northeast Quarter of the Northwest Quarter of Section 10, Township 36 North, Range 12 East of the Third Principal Meridian, in Cook County, Illinois.

Any highways or parts of highways adjacent to the above described real estate not located within a municipality,

is hereby annexed, added to, taken in and made a part of the corporate territorial limits of the Village of Orland Park, Cook County, Illinois.
