AN ORDINANCE PROVIDING FOR THE ANNEXATION OF CERTAIN
REAL ESTATE TO THE VILLAGE OF ORLAND PARK, COOK
COUNTY, ILLINOIS (13701 SOUTH 92ND AVENUE)

WHEREAS, there has been heretofore filed with the Village Clerk a petition requesting annexation of the real estate hereinafter described to the Village of Orland Park, Cook County, Illinois; and

WHEREAS, said real estate, commonly known as 13701 South 92nd Avenue, is not now within the present corporate territorial limits of the Village of Orland Park, but is contiguous to and adjoining the present corporate territorial limits of the Village of Orland Park; and

WHEREAS, said real estate is not now within the present corporate territorial limits of any city, village, or town; and

WHEREAS, all of the electors residing on said real estate have joined in said petition; and

WHEREAS, it is to the best interests of the Village of Orland Park that said real estate be annexed to the Village of Orland Park in accordance with the provisions of the Statutes of Illinois in such case made and provided.

NOW, THEREFORE, BE IT ORDAINED, by the President and Board of Trustees of the Village of Orland Park, Cook County, Illinois, as follows:

SECTION 1

That the material allegations of the annexation petition above-described heretofore filed with the Village Clerk are true and that said petition states the matters required to be stated in accordance with the Statutes of Illinois in such case made and provided.

SECTION 2

That the following described real estate, to-wit:

Lot 10 in Block 2 in First Addition to Orland Hills, being a Subdivision of the West 1/2 (except the North 1324.08 feet thereof) of the West 1/2 of the North East 1/4 of Section 3, Township 36 North, Range 12, East of the Third Principal Meridian, in Cook County, Illinois,

Any highways or parts of highways adjacent to the above-described real estate not located within a municipality,

is hereby annexed, added to, taken in and made a part of the corporate territorial limits of the Village of Orland Park, Cook County, Illinois.

SECTION 3

That the Village Clerk cause a copy of this Ordinance, together with an accurate map of the territory annexed, certified by the Village Clerk, to be recorded with the Recorder of Deeds of Cook County, Illinois, and to be filed with the County Clerk of Cook County, Illinois.

SECTION 4

That this Ordinance shall be in full force and effect from and after its passage and approval according to law.
