AN ORDINANCE PROVIDING FOR THE ANNEXATION OF CERTAIN REAL ESTATE TO THE VILLAGE OF ORLAND PARK, COOK COUNTY, ILLINOIS (13701 SOUTH 92ND AVENUE)
