AN ORDINANCE PROVIDING FOR THE ANNEXATION OF  
CERTAIN REAL ESTATE TO THE VILLAGE OF ORLAND  
PARK, COOK COUNTY, ILLINOIS (VERITAS EAST)

WHEREAS, there has been heretofore filed with the Village Clerk a Petition requesting annexation of the real estate hereinafter described to the Village of Orland Park, Cook County, Illinois; and

WHEREAS, said real estate is not now within the present corporate territorial limits of the Village of Orland Park, but is contiguous to and adjoining the present corporate territorial limits of the Village of Orland Park; and

WHEREAS, said real estate is not now within the present corporate territorial limits of any city, village or town; and

WHEREAS, all of the electors residing on said real estate have joined in said Petition; and

WHEREAS, it is to the best interests of the Village of Orland Park that said real estate be annexed to the Village of Orland Park in accordance with the provisions of the Statutes of Illinois in such case made and provided.

NOW, THEREFORE, BE IT ORDAINED, by the President and Board of Trustees of the Village of Orland Park, Cook County, Illinois, as follows:

## SECTION 1

That the material allegations of the annexation Petition above-described heretofore filed with the Village Clerk are true and that said Petition states the matters required to be stated in accordance with the Statutes of Illinois in such case made and provided.

## SECTION 2

That the following described real estate, to-wit:

### PARCEL 1:

Lots 4, 5, 6, 7 and 8 in Dodd's Subdivision of the West 10 rods of the East 48 rods of the Southeast 1/4 of the Southwest 1/4 of Section 13, Township 36 North, Range 12, East of the Third Principal Meridian, in Cook County, Illinois;

Also, the proposed to be vacated 33 foot wide 77th Avenue lying East of and adjacent to said Lots 4, 5, 6, 7 and 8 in Dodd's Subdivision; Also, the East 627 feet (except the South 500 feet thereof) of the Southeast 1/4 of the Southwest 1/4 of said Section 13, Township 36 North, Range 12, East of the Third Principal Meridian, in Cook County, Illinois.

PARCEL 4:

The South 550 feet of the West 132 feet of the East 627 feet of the Southeast 1/4 of the Southwest 1/4 of Section 13, Township 36 North, Range 12 East of the Third Principal Meridian, in Cook County, Illinois.

PARCEL 5:
