AN ORDINANCE PROVIDING FOR THE ANNEXATION OF CERTAIN REAL ESTATE TO THE VILLAGE OF ORLAND PARK, COOK COUNTY, ILLINOIS (VERITAS EAST)

WHEREAS, there has been heretofore filed with the Village Clerk a Petition requesting annexation of the real estate hereinafter described to the Village of Orland Park, Cook County, Illinois; and
