PAYMENT AND PERFORMANCE. Except as otherwise provided in this Mortgage. Grantor shall pay to Lender all amounts secured by this Mortgage as they become due, and shall strictly perform all of Grantor's obligations.



POSSESSION AND MAINTENANCE OF THE PROPERTY. Grantor agrees that its possession and use of the Property shall be governed by the following provisions:

Grantor shall procure and maintain policies of fire insurance with standard extended coverage endorsements on a replace filed basis for the full insurable value covering all Improvements on the Real Property in an amount sufficient to avoid application of any coinsurance climate, and with a standard mortgagee clause in favor of Lender. In no event shall the insurance be in an amount loss than \$80,000.00. Policies shall be written by such insurance companies and in such form as may be reasonably acceptable to Lender. Grantor shall deliver to Lender coverage from each insurer containing a stipulation that coverage will not be cancelled or diminished without a minimum of 10 days prior written notice to Lender.

Application of Proceeds. Grantor shall promptly notify Lender of any loss or damage to the Property. Lender may make proof of loss if Grantor take to do so within 15 days of the casualty. Lender may, at its election, apply the proceeds to the reduction of the Indebtedness or the restoration and repair of the Property. If Lender elects to apply the proceeds to restoration and repair, Grantor shall repair or replace the damaged or destroyed improvements in a manner satisfactory to Lender. Lender shall, upon satisfactory proof of such expenditute, pay or reimburse Grantor from the proceeds for the reasonable cost of repair or restoration if Grantor is not in default hereunder. Compliance With Prior Indebtedness. EXPENDITURES BY LENDER. If Grantor fails to comply with any provision of this Mortgage, including any obligation to maintain prior indebtedness in good standing as required below, or if any action or proceeding is commenced that would materially affect Lender's interests in the Property, Lender may, at its option, on Grantor's behalf take the required action and any amount that if expends in so doing shall be added to the Indebtedness. Amounts so added shall be payable on demand with interest from the date of expenditure until paid at the Note rate. The rights provided for in this section shall be in addition to any other rights or any remedies to which Lender may be entitled on account of the default. By taking the required action, Lender shall not cure the default so as to ber it from any remedy that it otherwise would have had.

WARRANTY: DEFENSE OF TITLE.

Title. Grantor warrants that it holds merchantable title to the Property in fee simple, free and clear of all fiens and encumbrances other than those set forth in the prior indebtedness section below or in any policy of title insurance issued in favor of, and accepted by, Lender in connection with this Mortgage.

Defense of Title. Subject to the exception in the paragraph above, Grantor warrants and will forever defend the title to the Property against the lawful claims of all persons. In the event any action or proceeding is commenced that questions Grantor's title or the interest of Lender under this Mortgage. Grantor shall defend the action at its expense. Grantor may be the nominal party in such proceeding but Lender shall be entitled to participate in the proceeding and to be represented in the proceeding by counsel of its own choice, and Grantor will deliver, or cause to be delivered, to Lender such instruments as may be requised by it from time to time to permit such participation.

Compliance With Laws. Grantus warrants that its use of the Property complies with all existing applicable laws, or dinances, and regulations of governmental authorities.

PRIOR INDEBTEDNESS. The lollowing r.o. roins concerning prior indebtedness are a part of this Mortgage:

Prior Lien. The lien of this Mortgage securing the Indebtedness is and remains secondary and inferior to the lien securing payment of a prior obligation in the form of Liberty Federal Savings & Loan Association of Chicago. The prior obligation has a current principal balance of approximately \$12,000.00 and is in the original principal amount of \$21,000.00. Grantor expressly covenants and agrees to pay or see to the payment of the prior indebtedness and to prevent any default thereunder.

Default. If the payment of any installment of principal or any interest on the prior indebtedness is not made within the time required by the note evidencing such indebtedness, or should an event of default occur under the instrument securing such indebtedness and not be cured during any applicable grace period therein, then the Indebtedness secured by this "Andgage shall, at the option of Lender, become immediately due and payable, and this Mortgage shall be in default.

No Modification. Grantor shall not eriter into any agreement with the holder of any mortgage, deed of trust, or other security agreement which has priority over this Mortgage by which that agreement is modified, ameniaed, extended, or renewed without the prior written consent of Lender. Grantor shall neither request nor accept any future advances under a prior mortgage, deed of trust, or other security agreement without the prior written consent of Lender.

CONDEMNATION.

Application of Net Proceeds. If all or any part of the Property is condemned, Lendy may at its election require that all or any portion of the net proceeds of the award be applied to the Indebtedness. The net proceeds of the award shall near the award after payment of all reasonable costs, expenses, and attorneys' fees necessarily paid or incurred by Grantor, or Lender in connection with the condemnation.

Proceedings. If any proceedings in condemnation are filed, Grantor snall promptly notify Lender in writing and Grantor shall promptly take such steps as may be necessary to defend the action and obtain the award. Addresses. FULL PERFORMANCE. Default on Indebtedness. Borrower falls to make any payment when due on the Indebtedness.

Default on Other Payments. Failure of Grantor within the time required by this Mortgage to make any payment for taxes or insurance, or for any other payment necessary to prevent filling of or to effect discharge of any lien.

Compliance Default. Failure to comply with any other term, obligation, covenant or condition contained in this Mortgage, the Note or in any of the Related Documents. If such a failure is curable and if Grantor has not been given a notice of a breach of the same provision of this Mortgage within the preceding 12 months, it may be cured (and no event of default will have occurred) if Grantor, after receiving written notice from Lender demanding cure of such failure: (a) cures the failure within 15 days; or (b) if the cure requires more than 15 days; immediately initiates steps sufficient to cure the failure and thereafter continues and completes all reasonable and necessary steps sufficient to produce compliance as soon as reasonably practical.

Termination of Existence. The death of any Grantor (if Grantor is an individual), insolvency of Grantor, appointment of a receiver for any part of Grantor's property, any assignment for the benefit of creditors, the commencement of any proceeding under any bankruptcy or insolvency laws by or against Grantor, or the Assolution or termination of Grantor's existence as a going business (if Grantor is a business).

RIGHTS AND REMEDIES ON DEFAULT. Upon the occurrence of erry event of default and at any time thereafter, Lender may exercise any one or more of the following rights and remedies, in addition to any other rights or emedies provided by law:

Accelerate Indebtedness. Lender shall have the right at its option (without notice to Grantor to declare the entire Indebtedness insmediately due and payable, including any prepayment penalty which Grantor would be required to pay.

UCC Remedies. With respect to all or any part of the Personal Property, concer shall have all the rights and remedies of a secured party under the fillinois Uniform Commercial Code.

Collect Income. Lender shall have the right, without notice to Grantor, to take push assion of the Property and collect the Income, including amounts past due and unpaid, and apply the net proceeds, over and above Lender's costs, at aimst the Indebtedness. In furtherance of this right, Lender may require any tenant or other user of the Property to make payments of rent or use fees directly to Lender. If the Income is collected by Lender, then Grantor irrevocably designates Lender as Grantor's attorney in fact to endorse instrumen's received in payment thereof in the name of Grantor and to negotiate the same and collect the proceeds. Payments by tenants or other users to Lender in russponse to Lender's derivand shall satisfy the obligations for which the payments are made, whether or not any proper grounds for the demand existed. Lower may exercise its rights under this subparagraph either in person, by agent, or through a receiver.

Appoint Receiver. Lender shall have the right to have a receiver appointed to take possession of all or any part of the Property, with the power to protect and preserve the Property, to operate the Property preceding foreclosure or sale, and to collect the income from the Property and apply the proceeds, over and above the cost of the receivership, against the Indebtedness. The receiver may serve without hond if permitted by law.
