## EXHIBIT A

### Parcel A

The South 287 Feet of the East 200 Feet lying West of and adjoining the West line of Hillside Avenue (except therefrom the South 133 Feet of East 150 Feet and except the North 100 Feet of the East 150 Feet) of the North East Fractional 1/4 of Section 18, Township 39 North, Range 12, East of the Third Principal Meridian, lying South of Indian Boundary Line in Cook County, Illinois.
