## THE COVENANTS, CONDITIONS AND PROVISIONS REFERRED TO ON PAGE 1 (THE REVERSE SIDE OF THIS TRUST DEED):

THE COVENANTS, QONDITIONS AND PROVISIONS REFERRED TO ON PAGE I (THE REVERSE SIDE OF TRIS TRUST DEED):

1. Mortgagers shall (a) promptly repair, restore or rebuild any buildings or improvements now or hereafter on the premises which may become damaged or be destroyed; (b) keep said premises in good condition and repair, without waste, and free from mechanic's or other liens or claims for lies not experied to the lien hereo; (c) pay when due any indebtedness which may be accured by a lien to charge on shoulders of the note; (d) complete within a reasonable time any buildings or buildings now or at any time in process of erection upon said premises; (c) comply with all requirements of law or nunicipal ordinances.

14. Trustee may resign by instrument in writing filed in the office of the Recorder or Registrar of Tilles in which this instrument shall have been recorded or filed. Any Successor in Trust hereunder shall have the idential title, powers and authority as are herein given Trustee.

16. Before releasing this trust deed. Trustee or successor shall receive for its services a fee as determined by its rate schedule in effect when the release deed is issued. Trustee or successor shall be entitled to reasonable compensation for any other act or service performed under any provisions of this trust deed. The provisions of the "Trust And Trustees Act" of the State of Illinois shall be applicable to this trust deed.
