THIS INDENTURE, Made this 3rd day of October, 1986,

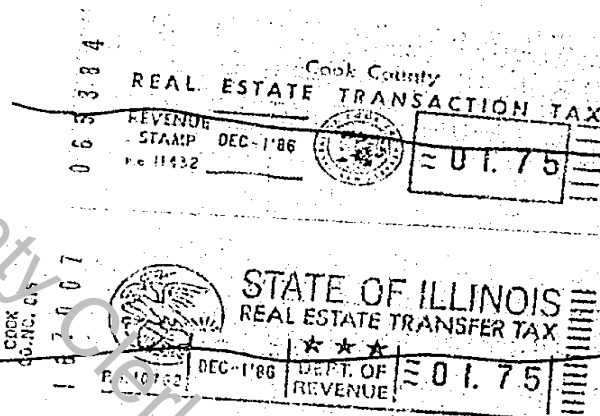

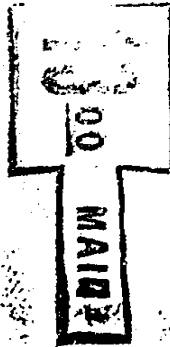
