1. Payment of Principal and Interest. Borrower shall promp to pay when due the principal of and interest on the debt, late charges if any and other charges evidenced by the Agreement.

2. Application of Payments. All payments received by Lender Circ's be applied to the annual fee billed and unpaid late charges and

other charges, interest due; and then, to principal.

3. Charges, Liens. Borrower shall pay all taxes, assessments, charges, line and impositions attributable to the Property which may attain priority over this Security Instrument, and leasehold payments or ground rents, it any. Borrower shall promptly furnish to Lender all notices of amounts to be paid under this paragraph. If the restoration or repair is not technomically feasible or Lender's security would be lessened, the insurance proceeds shall be applied to the sums secured by this Security Instrument, whether or not then due, and any excess paid to Borrower. If Borrower abandons the Property, or does not answer within 30 days a notice from Lender that the insurance carrier has offered to settle a claim, then Lender may collect the insurance proceeds. Lender may use the proceeds to repair or restore the Property or to pay sums secured by this Security Instrument, whether or not then due. The 30-day period will begin when the notice is given.

If under paragraph 19 the Property is acquired by Lender, Borrower's right to any insurance policies and proceeds resulting from damage to the Property prior to the acquisition shall pass to Lender to the extent of the sums secured by this Security Instrument immediately prior to the

5. Preservation and Maintenance of Property; Leaseholds. Borrower shall not destroy, damage or substantially change the Property allow the Property to deteriorate or commit waste. If this Security Instrument is on a leasehold, Borrower shall comply with the provisions of the lease; and if Borrower acquires fee title to the Property, the leasehold and fee title shall not merge unless Lender agrees to the merger in writing

6. Protection of Lender's Rights in the Property. is not personally obligated to pay the sums secured by this Security Instrument; and (c) agrees that Lender and any other Borrower may agree to extend, modify, forbear or make any accommodations with regard to the terms of this Security Instrument of the Agreement without that Borrower's consent. 11. Loan Charges. If the loan secured by this Security Instrument is subject to a law which sets maximum loan charges, and that law is finally interpreted so that the interest or other loan charges collected or to be collected in connection with the loan exceed the permitted limits, then: (a) any such loan charge shall be reduced by the amount necessary to reduce the charge to the permitted limit; and (b) any sums already collected from Borrower which exceeded permitted limits will be refunded to Borrower. If a refund reduces principal, the reduction will be treated as a partial prepayment without any prepayment charge under the Agreement. 12. Legislation Affecting Lender's Rights. If enactment or expiration of applicable laws has the effect of rendering any provision of the Agreement of this Security instrument unentorceable according to its terms, Lender, at its option, may require immediate payment in full of all sums secured by this Security instrument and may invoke any remedies permitted by paragraph 19. 13. Notices. Any notice to Borrower provided for in this Security Instrument shall be given by delivering it or by mailing it by first class mail unless applicable law requires use of another method. 14. Governing Law; Sey, at lifty. This Security instrument shall be governed by federal law and the law of Illinois. In the event that any provision or clause of this Security has trument or the Agreement conflicts with applicable law, such conflict shall not affect other provisions of this Security instrument or the Agreement, nich can given effect without the conflicting provision. To this end the provisions of this Security instrument and the Agreement are declared to be severable.

16. Transfer of the Property or a Barrofficial Interest in Borrower; Due on Sale. If all of any part of the Property or any interest in it is sold or transferred (or if a beneficial interest in Borrow as sold or transferred and Borrower is not a natural person) without Lender's prior written consent, Lender may, at its option, regulire immediate, as month in full of all sums secured by this Security Instrument. However, this option shall not be exercised by Lender If exercise is prohibited by Ir Jeral laws as of the date of this Security Instrument.

If Lender exercises this option, Lender shall give Br row or notice of acceleration. This notice shall provide a period of not less than 30 days from the date the notice is delivered or mailed within which, for rower must pay all sums secured by this Security Instrument. If Borrower fails to pay these sums prior to the expiration of this period, Lender may more any remedies permitted by this Security Instrument without further notice or demand on Borrower.

17. Borrower's Right to Reinstate: If Borrower meets of rtain conditions, Borrower shall have the right to have enforcement of this Security Instrument discontinued at any time prior to the entry of a judge not enforcing this Security Instrument. Those conditions are that Borrower: (a) pays Lender all sums which then would be due under this Security Instrument and the Agreement had no acceleration occurred; (b) cures any default of any other covenants or agreements; (c) pays all expenses incurred in enforcing this Security Instrument, including, but not limited to, reasonable attorneys less; (d) takes such action as Lender may real onably require to assure that the tien of this Security Instrument, Lender's rights in the Property and Borrower's obligation to pay the sums secured by this Security shall continue unchanged; and (e) not use this provision more frequently than once every live years. Upon reinstalement by Borrows, this Security Instrument and the obligations secured hereby shall remain fully effective as if no acceleration under paragraphs 12 and 16.
