DECLARATION OF CONDOMINIUM OWNERSHIP

THIS SUPPLEMENTAL DECLARATION is made and entered into this  
1<sup>st</sup> day of December, 1986, by COMMERCIAL NATIONAL BANK OF  
BERWYN, not individually, but solely as Trustee under Trust  
Agreement dated January 28, 1983, and known as Trust No. B30274 (the  
"Trustee"), and ERROL KIRSCH, the beneficiary of Trustee (the  
"Developer").

W I T N E S S E T H:

WHEREAS, by a Declaration of Condominium Ownership for Atrium  
Court Village Home Condominiums (the "Declaration") dated July 9,  
1986 and recorded July 9, 1986 in the office of the Recorder of  
Deeds of Cook County, Illinois, as Document No. 86285253, the  
Trustee submitted certain real estate to the provisions of the  
Illinois Condominium Property Act (the "Act"); and

WHEREAS, Article 22, subparagraph (f) of the Declaration  
reserves to the Trustee and Developer (without obtaining the consent  
of any Unit Owners to subdivide all units, other than those  
designated as finished on the Plat), the right to file such  
Amendments as are necessary, including amended Plats, to redefine  
the location of such subdivided Units and redetermine the percentage  
ownership of the subdivided Units; and

WHEREAS, the Trustee and Developer now desire to so subdivide  
the unfinished Units designated collectively as Unit A on Exhibit B  
to the Declaration.

NOW, THEREFORE, the Trustee and Developer do hereby  
supplement the Declaration as follows:

1. Trustee and Developer hereby add Unit 105 as a finished Unit from the previously unfinished Unit area collectively designated Unit A on Exhibit B to the Declaration.

2. Exhibit A of the Declaration is hereby amended by deleting said Exhibit A and substituting therefor Exhibit A which is attached hereto.

3. Exhibit B of the Declaration is hereby amended by substituting therefor Exhibit B which is attached hereto. The percentage of ownership in the common elements appurtenant to each Unit is hereby amended to the percentage as set forth in Exhibit B which is attached hereto.

4. Except as expressly set forth herein, the Declaration shall remain in full force and effect in accordance with its terms.

5. Terms used herein, if not otherwise defined herein, shall have the meanings set forth in the Declaration.

6. This Supplement is executed by Commercial National Bank of Berwyn not personally, but as Trustee as aforesaid, in the exercise of the power and authority conferred upon and vested in it as such Trustee. Commercial National Bank of Berwyn hereby warrants that it possesses full power and authority to execute this instrument. It is expressly understood and agreed that nothing herein shall be construed as creating any personal liability in Commercial National Bank of Berwyn.

7. All references in the Declaration to Commercial National Bank shall be deemed to refer to Commercial National Bank of Berwyn.
