ORDINANCE NO. 86- 38

AN ORDINANCE AUTHORIZING THE ANNEXATION
OF CERTAIN PROPERTY INTO THE VILLAGE OF JUSTICE

BE IT ORDAINED, by the President and Board of Trustees
of the Village of Justice, Cook County, Illinois, as follows:

WHEREAS, the following described territory is not within
the corporate limits of any municipality; and,

WHEREAS, legal notices regarding the intention of the
Village to annex said territory have been sent to all public
bodies required to receive such notice by State statute; and,

WHEREAS, the requisite public notice was published in
the DesPlaines Valley News, a newspaper of general circulation
within the territory to be annexed on the 27th day of November,
1986; and,

WHEREAS, copies of all such notices required to be
recorded, if any, have been recorded in the Office of the Recorder
of Deeds of Cook County; and,

WHEREAS, all documents and other necessary legal require-
ments are in full compliance with the statutes of the State of
Illinois, specifically, Chapter 24, Section 7-1-13, Illinois
Revised Statutes; and,

WHEREAS, it is in the best interests of the Village of
Justice, that said territory be annexed thereto,

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD
OF TRUSTEES OF THE VILLAGE OF JUSTICE, COOK COUNTY, ILLINOIS AS
FOLLOWS:

SECTION ONE

The territory described in Exhibit "A" of this ordinance, being
indicated on the attached map, is hereby annexed to the Village of
Justice, Cook County, Illinois.
