## RESOLUTION

WHEREAS, the Trustees of Schools of Township 42, Range 11, East of the Third Principal Meridian, Cook County, Illinois, has been furnished by the Board of Education of Township High School District No. 214, Cook County, Illinois, with a certified copy of a resolution of said Board of Education finding that in accordance with Section 5-29 of the School Code, the County of Cook, requires certain land for widening Hintz Road, title to which land is held by these Trustees for the use and benefit of Township High School District No. 214, Cook County, Illinois, and determining that said Board consents to said conveyance to the County of Cook, and further requesting that these Trustees of Schools execute a quit claim deed to said property in the form submitted.
