ORDINANCE NO. 86-24

ORDINANCE ANNEXING CERTAIN PROPERTY TO THE
ROSELLE PUBLIC LIBRARY DISTRICT
(SULLIVAN PROPERTY)

WHEREAS, the Village of Roselle has annexed the property legally described as follows:

That part of Block 6 and part of vacated alleys in said block described as beginning at the Northwest corner of said block and running thence east on the North line of said block, 313.35 feet to the place of beginning of the herein described tract; thence south on a line which forms a right angle with the North line of said block, 125.0 feet; thence easterly on a line parallel angles, 125.0 feet to the north line of said block; thence westerly on the north line thereof, 75.0 feet to the place of beginning, all in Boeger Estates Addition to Roselle, a Subdivision of the South 1/2 of the Southwest 1/4 of Section 24, Township 41 North, Range 10, East of the Third Principal Meridian, in Cook County, Illinois,

commonly known as 31 West Schreiber, Roselle, Illinois, which property is contiguous to the Roselle Public Library District boundaries; and

WHEREAS, the Roselle Public Library District is a duly organized and existent public library district and under Ill. Rev. Stat., ch. 81, §1001-8(2), said property may be annexed by the District subject to certain notice requirements; and

WHEREAS, there are residents living upon the subject property;

NOW, THEREFORE, be it ordained by the Board of Trustees of the Roselle Public Library District as follows:

Section 1. The foregoing recitals are incorporated by reference.

Section 2. The above-described property is hereby annexed by the Roselle Public Library District.

NOTICE

Notice is hereby given that the Roselle Public Library District annexed the aforesaid property on the 8th day of October, 1986. The registered voters residing on the subject property may request that the annexation be made the subject matter of a referendum to be held on April 7, 1987 by filing a petition for referendum signed by at least one registered voter of the subject property or 736 voters of the District. Said petition must be filed with the Secretary of the District no later than November 17, 1986, which is 30 days after the publication of this notice.

4. All ordinances in conflict herewith are hereby repealed.
