ORDINANCE ANNEXING CERTAIN PROPERTY TO THE  
ROSELLE PUBLIC LIBRARY DISTRICT  
(MAYWOOD-PROVISO STATE BANK  
TRUST #6390 PROPERTY)

WHEREAS, the Village of Roselle has annexed the property legally described as follows:
