

LIMITED POWER OF ATTORNEY

This limited power of attorney has been executed and is effective as of the 1st day of December, 1986, and the same shall continue in full force and effect until revoked in writing by the undersigned.

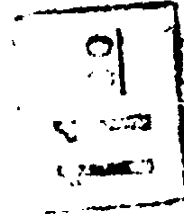
