LOAN MODIFICATION AGREEMENT

This Agreement made this 25th day of September, 1986
 by and between FIRST NATIONAL BANK OF SKOKIE as Trustee under Trust Agreement dated
 October 1, 1977 and known as Trust Number 50102T ("Mortgagor")
 FIRST NATIONAL BANK OF SKOKIE, A National Banking Association ("Mortgagee")

WITNESSETH:

WHEREAS, Mortgagor has heretofore made, executed and delivered the following:

- A. Mortgage Note dated May 10th, 1983 in the original principal sum of --Two hundred Twenty Five Thousand and 00/100----- Dollars (\$ 225,000.00) made by Mortgagor to Mortgagee ("Mortgage Note");
- B. Mortgage or Trust Deed (hereinafter referred to as "Mortgage") of even date with and securing the Mortgage Note executed, acknowledged and delivered by Mortgagor to Mortgagee and recorded in the Office of the Recorder of Deeds of Cook County, Illinois on May 17th, 1983, as Document Number 26 607 428 (Mortgage);

WHEREAS, the Mortgage constitutes a first lien upon certain real property situated in Cook, Illinois and legally described as follows:

LOT 3, MAKING AN ANGLE TO THE RIGHT OF 125 DEGREES 55 MINUTES WITH THE PROLONGATION OF THE LAST DESCRIBED COURSE FOR A DISTANCE OF 210.45 FEET TO AN IRON STAKE, THENCE NORTHEASTERLY (PARALLEL TO MILWAUKEE) FOR A DISTANCE OF 206.0 FEET TO AN IRON STAKE, THENCE EASTERLY (PARALLEL TO THE NORTH LINE OF LILAC AVENUE) FOR A DISTANCE OF 210.45 FEET TO THE PLACE OF BEGINNING, IN NORTHELD TOWNSHIP, IN COOK COUNTY, ILLINOIS EXCLUDING FROM THE ABOVE DESCRIBED TRACT THE FOLLOWING DESCRIBED REAL ESTATE:

THE PART OF LOT 3 IN SUPERIOR COURT SECTION OF LOTS 6 AND 8 IN COUNTY CLERK'S DIVISION IN THE WEST END OF SECTION 29 AND ALSO OF LOTS 7 AND 8 IN COUNTY CLERK'S DIVISION OF SECTION 30, TOWNSHIP 42 NORTH, RANGE 12 EAST OF THE THIRD PRINCIPAL MERIDIAN BOUNDED AND DESCRIBED AS FOLLOWS:

THENCE NORTHEASTERLY ON SAID PARALLEL LINE A DISTANCE OF 206 FEET, THENCE EASTERLY PARALLEL WITH THE NORTH LINE OF LILAC AVENUE TO THE POINT OF BEGINNING (EXCLUDING THEREFROM THAT PART LYING NORTHEASTERLY OF A LINE 33 FEET SOUTHEASTERLY OF AND PARALLEL WITH THE CENTER LINE OF SAID MILWAUKEE AVENUE) IN COOK COUNTY, ILLINOIS.
