
Amendment to Mortgace and Assignment of Leases and Rents


This Amendment dated as of the 2nd day of September, 1986, is between The Pirst National Bank of Chicago, a national banking association (Mortgagee), and LaSalle National Bank, a national banking association, not personally but as Trustee under Trust Agreements dated May 22, 1981, May 22, 1981, and August 10, 1981 and known as Trust Nos. 104006, 104022 and 104255, respectively (collectively, Mortgagor).

- A. Mortgagor has executed and delivered to Mortgagee a certain Mortgage and Assignment of Leases and Rents lated October 5, 1983, recorded in the Recorder's Office of Cook County, Illinois as Document 26843061 (the Mortgage), encumbering the real estate described on Exhibit A attached hereto.
- B. The Mortgage secures payment of a ce:tain Note in the principal amount of \$8,300,000 dated October 5, 1983 executed by Mortgagor (the Note); and
- C. Mortgager and Mortgagee desire to amend the Mortgage to increase the amount of indebtedness secured thereby.

NOW, THEREFORE, in consideration of the premises and the mutual covenants hereinafter contained, it is hereby agreed as follows:

- 1. Each and every reference in the Mortgage to the "Note" shall mean the Note as amended of even date he ewith to increase the principal amount thereof from \$8,300,000 to \$8,875,000.
- 2. Each and every reference in the Mortgage to the "Indebtedness" shall include principal and ill interest thereon as set forth in the Note, as amended of even date herewith to increase the principal amount thereof from \$9,300,000 to \$8,875,000.
- 3. Each and every reference in the Mortgage to the "Loan Agreement" shall mean the Loan Agreement, as amended of even date herewith.
- 4. Except as specifically modified herein, the Mortgage remains in full force and effect.
- 5. This Amendment is executed by LaSalle National Bank, not personally but solely as Trustee as aforesaid in the exercise of the power and authority conferred upon and rested in it as such Trustee (and said LaSalle National Bank hereby warrants that it possesses full power and authority to execute this Amendment), and it is expressly understood and agreed that nothing herein contained shall be constructed as creating any liability on said LaSalle National Bank personally to pay the Note as amended, or any indebtedness accruing hereunder, all such liability, if any,

being expressly waived by Mortgagee, and that so far as LaSalle National Bank personally is concerned, the Mortgagee shall look solely to the property subject to the Mortgage for the payment thereof, by the enforcement of the lien created by the Mortgage, and other security documents; provided, however, nothing herein shall affect or limit the personal liability of the beneficiary of Mortgagor or of any guarantors of the Note.
