EASEMENT ABROGATION AGREEMENT

This Easement Abrogation Agreement ("Agreement"), is made as of December, 1986 between Klefstad Engineering Co., Inc. ("Klefstad"), and LaSalle National Bank, not personally, but as successor trustee under a trust agreement dated October 2, 1975 and known as Trust No. 10-21466-08 ("LaSalle").

WHEREAS, LaSalle is the owner of the following described real estate ("Parcel A"):

The West ½ of Lot 14 in Block 38 in Montrose Subdivision of Section 15, Township 40 North, Range 13 East of the Third Principal Meridian, in Cook County, Illinois; and PlN: 13-15-130-030-0000

WHEREAS, Klefstad is the owner of the following described real estate ("Fercel B"):

WHEREAS, Klefstad's and LaSalle's respective predecessors in title previously entered into e certain Easement Agreement dated December 8, 1951 and recorded December 12, 1951 as Document No. 15235758, pursuant to which certain easements were granted to the then owner of Parcel A over portions of Parcel B; and

WHEREAS, Klefstac and LaSalle now wish to abrogate all of said easements;

NOW, THEREFORE, Klefstad and LaSalle hereby agree as follows:

- 1. All of the easements previously contained and granted pursuant to the above-described Document No. 15255 58, are hereby abrogated and terminated effective as of the date hereof.
- 2. This Agreement is executed by LaSalle National Bank, not personally, but solely as trustee under that certain Trust Agreement dated October 2, 1975 and known as Trust No. 10-21466-08, in the exercise of the power and authority conferred upon and vested in it as such trustee. All of the terms, provisions, stipulations, covenants and conditions to be performed by L.Salle National Bank are undertaken by it solely as trustee, as aforesaid, and not individually, and all statements herein made are made on information and belief and to be construed accordingly, and no personal liability shall be asserted or be enforceable against LaSalle National Bank by reason of any of the terms, provisions, stipulations, covenants or statements contained in this Agreement.
