2. That the Certificate, as amended, is hereby further amended by restating, in its entirety, Paragraph VI as follows:




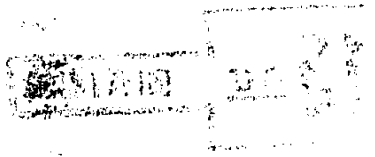
