## MORTGAGE

THIS INDENTURE, made December 1, 1986, between CHICAGO TITLE AND TRUST COMPANY, not personally but as Trustee under the provisions of a Trust Agreement dated September 25, 1986, and known as Trust Number 1089074 (herein referred to as "Mortgagor") and MANUFACTURERS BANK, 1200 North Ashland Avenue, Chicago, Illinois 60622 (herein referred to as "Mortgagee").

### W I T N E S S E T H:

THAT WHEREAS, the Mortgagor has concurrently herewith executed a Mortgage Installment Note bearing even date herewith in the principal sum of Three Hundred Eighty Five Thousand and No/Hundredths (\$385,000.00) Dollars, payable to Mortgagee and delivered, in and by which said Note the Maker promises to pay said principal sum in monthly installments of principal in the amount of Three Thousand Two Hundred and No/Hundredths (\$3,200.00) Dollars plus interest payable monthly in arrears as billed by the Payee at a rate equal to one (1%) percent in excess of the Prime Rate, as hereinafter defined, from time to time in effect, such monthly payments of principal and interest being payable on the first day of each month, commencing January 1, 1987, with a final payment of the entire remaining balance of principal and interest being due and payable on December 1, 1991.

All such payments on account of the indebtedness evidenced by said note to be first applied to interest on the unpaid principal balance and the remainder to principal. Interest after maturity, whether by reason of acceleration or otherwise, shall bear interest at a rate equal to three (3%) percent in excess of the Prime Rate, as hereinafter defined, and all of said principal and interest being made payable at the main banking facility of MANUFACTURERS BANK, 1200 North Ashland Avenue, Chicago, Illinois 60622. Interest shall be computed on the basis of a 360-day year for the actual number of days elapsed unless otherwise specified herein.

NOW, THEREFORE, Mortgagor to secure the payment of the said principal sum of money and said interest in accordance with the terms, provisions and limitations of this Mortgage, and also in consideration of the sum of One Dollar in hand paid, the receipt whereof is hereby acknowledged, does by these presents, grant, remise, release, and convey unto the Mortgagee, his successors and assigns, the following described Real Estate situate, lying and being in the County of Cook, and the State of Illinois, to wit:

4. In case of default therein, Mortgagee may, but need not, make any payment or perform any act hereinbefore required of Mortgagor in any form and manner deemed expedient, and may, but need not, make full or partial payments of principal or interest on prior encumbrances, if any, and purchase, discharge, compromise or settle any tax lien or other prior lien or title or claim thereof, or redeem from any tax sale or forfeiture affecting said premises or contest any tax or assessment. All moneys paid for any of the purposes herein authorized and all expenses paid or incurred in connection therewith, including attorneys' fees, and any other moneys advanced by Mortgagee to protect the mortgaged premises and the lien hereof, plus reasonable compensation to Mortgagee for each matter concerning which action herein authorized may be taken, shall be so much additional indebtedness secured hereby and shall become immediately due and payable without notice and with interest thereon at the rate stated above. there be rents, issues, and profits, and all other powers which may be necessary or are usual in such cases for the protection, possession, control, management and operation of the premises during the whole of said period. 

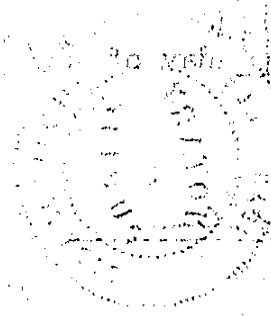
