3. Application of Payments. Unless applicable law provides otherwise, "a p. yments received by Lender under the Note and Paragraph 1 hersel shall be applied by Lender first in payment of interest payable on the Note, then to the principal of the Note, and then to interest and principal on any Future Advances.
