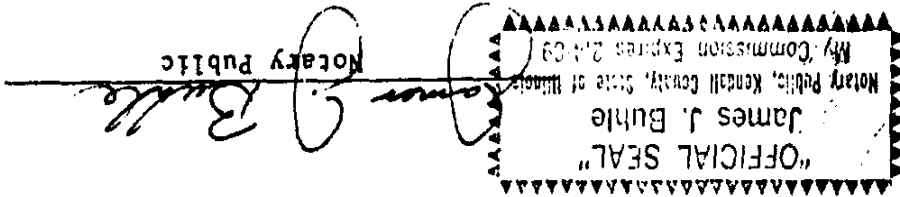



Except as to the land hereinabove specifically described said Grant of Easement recorded as Document No. 17878840 shall be and remain in full force and effect.
