THE COURT FINDS: (EO-22785) 4/11/86 86-02207-A-1-100

1. That on the premises commonly known as 02207 N KILDARE AV Chicago, Illinois, there is a 0002 unit building.
2. That the legal description of said premises is *LOT 38 IN THE RESUBD. OF LOTS 73-120 INCLUSIVE IN SAM BROWN JR'S PENNOCK SUBDN OF THE NE 1/4 OF SECT 34 TWSP 40 NORTH RANGE 13 LYING EAST OF THE 3RD PRINCIPAL MERIDIAN IN COOK COUNTY ILLINOIS PI # 13 34 211 018.
