as solidly filled in and indicated by the words "TO BE VACATED" on the Plat hereto attached, which Plat for greater certainty is hereby made a part of this Ordinance, be and the same is hereby vacated, inasmuch as the same is no longer required for public use and the public interest will be served by such vacation; provided, however, that there is reserved to the Commonwealth Edison Company, the Northern Illinois Gas Company and the Illinois Bell Telephone Company, their successors and assigns, the right, permission and authority to maintain their property and rights-of-way and easements to construct, operate, maintain and renew their poles, wires, cables, mains and necessary fixtures for the transmission and distribution of electricity, for the carrying and distributing of gas and for the transmission of communications, together with the right of access to the same for the maintenance thereof, and also to trim from time to time such trees, bushes and saplings as may be reasonably required for the construction and efficient operation of said poles, wires, cables, mains and necessary fixtures in the aforesaid vacated street, provided further that there is reserved to the Village of Indian Head Park the right to continue the use of, replace, repair and maintain any sewer, water main or conduit, or other municipal utility now located within such street, and further provided that the Village of Indian Head Park reserves unto itself an easement over and under the five feet west of the

Indian Head Park Unit #4, being a Subdivision of that part of the North-East 1/4 of Section 19, Township 38 North, Range 12, East of the Third Principal Meridian, which lies west of and adjoining Lot 33 in said Subdivision and East of and adjoining Lot 34 in said Subdivision, and South of the South line of Tecumseh Lane and North of the South line of said Subdivision, all in Cook County, Illinois,

SECTION 1. That part of Pontiac Drive as dedicated in:

WHEREAS, the President and Board of Trustees of the Village of Indian Head Park, after due investigation and consideration, have determined that it is to the best interest of the Village that the street hereinafter described be vacated; NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Indian Head Park, Cook County, Illinois, that:

SECTION 2. That a certified copy of this Ordinance with a plat of the street to be vacated, together with additional copies required for recording, shall be recorded by the Village Clerk in the office of the Recorder of Deeds of Cook County, Illinois.
