### NOTICE OF LIEN

The Lien Creditor-Supplier, VILLAGE OF BROADVIEW, an Illinois Municipal Corporation, pursuant to the provisions of Section 11-139-8 of the Illinois Municipal Code (Chapter 24, Illinois Revised Statutes (1975), hereby files notice of a lien in its favor in the amount of Four Hundred Seventy-Eight and 90/100 DOLLARS (\$478.90) against the following described real estate: Tax Index No. 15-22-111-059 all in The North 20 feet of Lot 309 and the South 30 feet of Lot 310 in the Cummings & Foreman Addition, a subdivision of the West 1/2 of the North West 1/4 of Section 21, Township 39 North, Range 12 of Block 111 in Cook County, Illinois commonly known as 2305 South 22nd Avenue Broadview, Illinois.

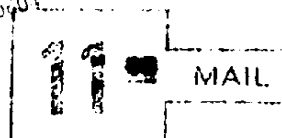
