It is the intent of the above trust to be a trust for the benefit of the children of the settlor, in accordance with the terms set forth in the instrument, and the settlor is hereby directed not to require or cause the trust to be terminated, modified, or otherwise affected in any way.

The trustee of this trust shall have the right to sell, lease, convey, or otherwise dispose of any or all of the trust property in such a manner as to best carry out the purposes of the trust, and the trustee shall not be liable for any such action.

In the event of the death of the trustee, the trust shall continue in effect until the death of the last surviving trustee, and the trustee shall have the right to appoint one or more co-trustees, and the trustee shall have the right to resign or be removed from office. The trustee shall also have the right to borrow trust property for the purposes of the trust, and the trustee shall have the right to invest the trust property in such a manner as to best carry out the purposes of the trust.

The trustee shall have the right to sell, lease, convey, or otherwise dispose of any or all of the trust property in such a manner as to best carry out the purposes of the trust, and the trustee shall not be liable for any such action. The trustee shall also have the right to borrow trust property for the purposes of the trust, and the trustee shall have the right to invest the trust property in such a manner as to best carry out the purposes of the trust.

TO HAVE AND TO HOLD the said premises with the appurtenances, upon the trust and for use and purpose herein and in this trust agreement.

CONFEYANCE IS MADE PURSUANT TO DIRECTION AND WITH AUTHORITY TO CONVEY DIRECTLY THE TRUST GRANTER NAMED HEREIN. THE POWERS AND AUTHORITY CONFERRED UPON SAID GRANTER ARE RECITED AND INCORPORATED HEREIN BY REFERENCE. SAID DEED IS EXECUTED PURSUANT TO AND IN THE EXERCISE OF THE POWER AND AUTHORITY GRANTED TO AND VESTED IN SAID TRUSTEE BY THE TERMS OF SAID DEED IN TRUST DELIVERED SAID TRUSTEE IN PURSUANCE OF THE TRUST AGREEMENT ABOVE MENTIONED.
