# UNOFORDINANCE NO AL

AN ORDINANCE AMENDING TITLE 5, CHAPTER 10, ENTITLED "VILLAGE WATERWORKS AND SEWERAGE SYTEM," OF THE RIVER FOREST VILLAGE CODE BY AMENDING SECTION 5-10-3, EN-TITLED "RATES FOR SEWERAGE SERVICE."

BE IT ORDAINED by the President and Board of Trustees of

the Village of River Forest, County of Cook, State of Illinois:

Section 1: That Title 5, Chapter 10, entitled "Village Waterworks and Sewerage System," of the River Forest Village Code, be amended so that Section 5-10-3, entitled "Rates for Sewerage Service". reads as follows:

#### 5-10-3: RATES FOR SEWERAGE SERVICE:

- There shall be charged for sewerage service for each quarter-yearly period twenty five cents per one hundred cubic feet of metered water used on each independent premises, including elementary schools, high schools, colleges, churches, Park District, Public Library, and Community Center.
- Livery independent premises connected with the Village suwirage system shall be assessed the minimum rate specified herein for such premises, and such minimum rate snall be due and payable each three month period, when billed. For the purposes of this Chapter, each unit in a rulyiple family dwelling shall be considered as a dwelling occupied by one family and as an independent premises. Minimum rates for independent premises for each three mont' ) eriod are as follows:

Dwellings ----- \$ 1.80 Business Establishmer's ----- \$ 1.80

Section 2: That all ordinances or parts of ordinances in conflict with this ordinance are hereby expressly repealed.

Section 3: This ordinance shall be in full force and effect from and after its passage, approval and publicacion as provided by law.
