- (2) The Mortgagor further covenants and agrees that the sum of \$14,975.00 advanced by the City will be used solely for the rehabilitation of the structure on the above described property and that said sum will be paid to all obligees, upon receipt of properly executed releases of contractors, sub-contractors, and materialmen claims for lien.
- (4) The Mortgagor further agrees that the sum advanced by the City is in the nature of a loan payable as in the conditions of the note bearing even date herewith.
