Shapiro Management and Shapiro Management was owner's contractor for the improvement thereof. That on August 28, 1985, said contractor made a subcontract with the claimant to provide material and labor for acoustics for and in said improvement, and that on October 11, 1985, the claimant completed thereunder all that was required to be done by said contract. That at the special instance and request of said contractor the claimant furnished extra and additional materials at and extra and additional labor on said premises of the value of \$ NONE, and completed same on 19. That said contractor is entitled to credits of account thereof as follows: NONE, leaving due unpaid and owing to the claimant, after allowing all credits, the sum of Two Thousand Two Hundred Thirty-six and 50/100ths. (\$2,236.92) Dollars, for which, with interest, the claimant claims a lien on said land and improvements, and on the moneys or other considerations due or to become due from the owner under said contract against said contractor and owner.
