INSTRUCTIONS

(b) that such conveyance or other instrument was executed in accordance with the trusts, conditions and limitations contained in this Indenture and in said Trust Agreement or in a's amendments thereof, if any, and binding upon all beneficiaries thersunder. (c) that said Trustee, or any successor in trust, was duly authorized and empowered to execute and deliver every such deed, trust deed, lesse, mortgate or other instrument and (d) if the conveyance is made to a successors in trust, that such successors in trust have been properly appointed and are fully vested with all the title, estate, rights, powers, authorities, duties and obligations of its, his or their prodecessor in trust.

The interest of each and every beneficiary hereunder and under said Trust Agreement and of all persons plaining under them or any of them shall be only in the earnings, avails and proceeds arising from the sale or any other disposition of said real estate, and such interest is hereby declared to be personal property, and no beneficiary hereunder shall have any title or interest, legal or equitable, in or to said real estate as such, but only an interest in earnings, avails and proceeds thereof as aforesaid, the intention hereof being to vest in said Grantee the entire legal as with ble title in fee simple, in and to all of the real estate above described.
