DEFAULT JUDGMENT

This matter coming to be heard on the Motion of Federal Deposit Insurance Corporation, as Receiver of the Des Plaines Bank ("FDIC") for default judgment against Jacqueline Ross ("Defendant"), the Court having reviewed the pleadings and affidavits submitted in support of FDIC's Motion, the Court being otherwise duly advised in the premises, due notice having been given, the Court finds as follows:

(i) That Defendant has been duly served with process by FDIC and this Court has in personam jurisdiction to enter judgment against Defendant;

(ii) That Defendant has failed to answer or otherwise plead in response to FDIC's Complaint;

(iii) That as of October 29, 1985, the Defendant is indebted to FDIC in the sum of \$400,806.00; and

(iv) That there is no just reason for staying execution of judgment against Defendant.

WHEREFORE, IT IS HEREBY ORDERED:

(1) Judgment is hereby entered against Defendant and in favor of FDIC in the amount of \$400,806.00;
