(2) Situs Of Property Subject To Lien. For purposes of paragraphs (1) and (4), property shall be deemed to be situated—

(A) Real Property. In the case of real property, at its physical location; or

(B) Personal Property. In the case of personal property, whether tangible or intangible, at the residence of the taxpayer at the time the notice of lien is filed.

for purposes of paragraph (1) (B), the residence of a corporation or partnership shall be deemed to be the place at which the principal executive office of the business is located, and the residence of a taxpayer whose residence is without the United States shall be deemed to be in the District of Columbia.

(3) Form. — The form and content of the notice referred to in subsection (a) shall be prescribed by the Secretary. Such notice shall be valid notwithstanding any other provision of law regarding the form or content of a notice of lien.

(a) Refiling Of Notice. — For purposes of this section—

(1) General Rule. — Unless notice of lien is filed in the manner prescribed in paragraph (2) during the required refiling period, such notice of lien shall be treated as filed on the date on which it is filed (in accordance with subsection (1)) after the expiration of such refiling period.

(2) Place For Filing. — A notice of lien filed during the required refiling period shall be effective only if—

(i) such notice of lien is filed in the office in which the prior notice of lien was filed; and

(ii) in the case of real property, the fact of refiling is entered and recorded in an index to the title of such property (see Reg. (C)(2)(A)(2)(b)(i)).

(3) in any case in which, 90 days or more prior to the date of a refiling of notice of lien under subparagraph (A), the Secretary receives written information (in the manner prescribed in regulations issued by the Secretary) concerning a change in the taxpayer's residence, if a notice of such lien is also filed in accordance with subsection (1) in the State in which such residence is located.
