All insurance shall be carried in companies approved by the Mortgagee and the policies and renewals thereof shall be held by the Mortgagee and have attached thereto loss payable clauses in favor of and in form acceptable to the Mortgagee. In event of loss Mortgagor will give immediate notice by mail to the Mortgagee, who may make proof of loss if not made promptly by Mortgagor, and each insurance company concerned is hereby authorized and directed to make payment for such loss directly to the Mortgagee instead of to the Mortgagor and the Mortgagee jointly, and the insurance proceeds, or any part thereof, may be applied by the Mortgagee at its option either to the reduction of the indebtedness hereby secured or to the restoration or repair of the property damaged. This Rider, dated the 10TH day of JANUARY----, 1986, amends the Mortgage of even date by and between TERRY L. STREY AND JILL A. STREY----, the Mortgagor, and Indiana Tower Service Corporation, the Mortgagee, as follows:

- 1. Subsection (a) of Faragraph 2, Page 2 is deleted.
- 2. Subsection (c)(I) of Paragraph 2, Page 2 is deleted.
- 3. In the third sentence of Paragraph 3, Page 2, the words "all payments made under the provisions of (a) of paragraph 2, Page 2 hereof which the Mortgagee has not become obligated to pay to the Secretary of Housing and Urban Development and" are deleted.
- 4. The fourth sentence of Paragraph 3, Page 2 is amended by insertion of a period after ". . . then remaining unpaid under said note" and deletion of the remainder of the sentence.
- 5. Paragraph 2, Page 3 is amended by the addition of the following:

"This option may not be exercised when the ineligibility for insurance under the National Housing Act is due to the Mortgagee's failure to remit the mortgage insurance premium to the Department of Housing and Urban Development."
