All insurance shall be carried in companies approved by the Mortgagee and the policies and renewals thereof shall be held by the Mortgagee and have attached thereto loss payable clauses in favor of and in form acceptable to the Mortgagee. In event of loss Mortgagor will give immediate notice by mail to the Mortgagee, who may make proof of loss if not made promptly by Mortgagor, and each insurance company concerned is hereby authorized and directed to make payment for such loss directly to the Mortgagee instead of to the Mortgagor and the Mortgagee jointly, and the insurance proceeds, or any part thereof, may be applied by the Mortgagee at its option either to the reduction of the indebtedness hereby secured or to the restoration or repair of the property damaged. In event of foreclosure of this mortgage or other transfer of title to the mortgaged property in extinguishment of the indebtedness secured hereby, all right, title and interest of the Mortgagor in and to any insurance policies then in force shall pass to the purchaser or grantee.

If the total of the payments made by the Mortgagee under subsection (b) of the preceding paragraph shall exceed the amount of the payments actually made by the Mortgagee for ground rents, taxes, and assessments, or insurance premiums, as the case may be, such excess, if the loan is current, at the option of the Mortgagee, shall be credited on subsequent payments to be made by the Mortgagee, or refunded to the Mortgagee. If, however, the monthly payment made by the Mortgagee under subsection (b) of the preceding paragraph shall not be sufficient to pay ground rents, taxes, and assessments, or insurance premiums, as the case may be, when the same shall become due and payable, then the Mortgagee shall pay to the Mortgagee any amount necessary to make up the deficiency, on or before the date when payment of such ground rents, taxes, assessments, or insurance premiums shall be due. RIDER TO STATE OF ILLINOIS
MORTGAGE HUD-92116M (10/85)

This rider attached to and made part of the Mortgage between JOSE A. CRUZ AND DAISY CRUZ, HIS WIFE Mortgagor, and FLEET MORTGAGE CORP. Mortgagee, dated JANUARY 17, 1986 revises said Mortgage as follows:

1. Page 2, the fourth covenant of the Mortgage is amended to read:

That, together with, and in addition to, the monthly payments of principal and interest payable under the terms of the note secured hereby, the Mortgagor will pay to the Mortgagee, on the first day of each month until the said note is fully paid, the following sums:

- (a) A sum equal to the ground rents, if any, next due, plus the premiums that will next become due and payable on policies of fire and other hazard insurance covering the mortgaged property, plus taxes and assessments next due on the mortgaged property (all as estimated by the Mortgagee) less all sums already paid therefor divided by the number of months to elapse before one month prior to the date when such ground rents, premiums, taxes and assessments will become delinquent, such sums to be held by Mortgagee in trust to pay said ground rents, premiums, taxes and special assessments; and
- (b) All payments mentioned in the two preceding subsections of this paragraph and all payments to be made under the note secured hereby shall be added together and the aggregate amount thereof shall be paid by the Mortgagor each month in a single payment to be applied by the Mortgagee to the following items in the order set forth:
 - (I) ground rents, if any, taxes, special assessments, fire, and other hazard insurance premiums;
 - (II) interest on the note secured hereby; and
 - (III) amortization of principal of the said note.

Any deficiency in the amount of any such aggregate monthly payment shall, unless made good by the Mortgagor prior to the due date of the next such payment, constitute an event of default under this mortgage. The Mortgagee may collect a "late charge" not to exceed four cents (4c) for each dollar (\$1) for each payment more than fifteen (15) days in arrears, to cover the extra expense involved in handling delinquent payments.

If the total of the payments made by the Mortgagor under subsection (a) of the preceding paragraph shall exceed the amount of the payments actually made by the Mortgagee for ground rents, taxes, and assessments, or insurance premiums, as the case may be, such excess, if the loan is current, at the option of the Mortgagor shall be credited on subsequent payments to be made by the Mortgagor, or refunded to the Mortgagor. If, however, the monthly payments made by the Mortgagor under subsection (a) of the preceding paragraph shall not be sufficient to pay ground rents, taxes, and assessments, or insurance premiums, as the case may be, when the same shall become due and payable, then the Mortgagor shall pay to the Mortgagee any amount necessary to make up the deficiency, on or before the date when payment of such ground rents, taxes, assessments, or insurance premiums shall be due. If at any time the Mortgagor shall tender to the Mortgagee, in accordance with the provisions of the note secured hereby, full payment of the entire indebtedness represented thereby, the Mortgagee shall, in computing the amount of such indebtedness, credit to the account of the Mortgagor any balance remaining in the funds accumulated under the provisions of subsection (a) of the preceding paragraph. If there shall be a default under any of the provisions of this mortgage resulting in a public sale of the premises covered hereby, or if the Mortgagee acquires the property otherwise after default, the Mortgagee shall apply, at the time of the commencement of such proceedings or at the time the property is otherwise acquired, the balance then remaining in the funds accumulated under subsection (a) of the preceding paragraph as a credit against the amount of principal then remaining unpaid under said note.

2. Page 3, the third paragraph is amended to add the following sentence:

This option may not be exercised by the Mortgagee when the ineligibility for insurance under the National Housing Act is due to the Mortgagee's failure to pay the mortgage insurance premium to the Department of Housing and Urban Development.

REPORT OF THE COMMISSION ON THE JUDICIAL BRANCH

CHAPTER 1. INTRODUCTION

The Commission on the Judicial Branch was organized in 1985 to study the structure and administration of the judicial branch of the State of Illinois. The Commission's mandate was to identify areas for improvement and to recommend changes to the Illinois Constitution and the State's judicial system.

The Commission's work has been guided by the following principles: (1) the independence of the judiciary; (2) the integrity of the judicial process; (3) the efficiency of the courts; and (4) the accessibility of the courts to the people. The Commission has held numerous public hearings and has received many suggestions from judges, lawyers, and lay citizens.

The Commission's report is organized into several chapters. Chapter 1, "Introduction," sets the stage for the report. Chapter 2, "The Structure of the Judicial Branch," discusses the current structure of the courts and proposes changes to improve efficiency and reduce costs. Chapter 3, "The Administration of the Courts," discusses the current administration of the courts and proposes changes to improve the quality of the judiciary and the public's confidence in the courts.

Chapter 4, "The Selection of Judges," discusses the current process of selecting judges and proposes changes to improve the quality of the judiciary. Chapter 5, "The Funding of the Courts," discusses the current funding of the courts and proposes changes to ensure that the courts have sufficient resources to operate effectively. Chapter 6, "The Public's Access to the Courts," discusses the current access to the courts and proposes changes to improve the courts' accessibility to the people.

The Commission believes that the changes proposed in this report are essential for the continued improvement of the Illinois judicial system. We urge the General Assembly to take prompt action on these recommendations. We also urge the public to support the reforms proposed in this report.

The Commission on the Judicial Branch is composed of members from the judiciary, the executive branch, and the public. The Commission's work has been supported by the Illinois State Bar Association and the Illinois Judicial Conference. The Commission's report is the result of a year-long study and is intended to provide a comprehensive and balanced view of the current state of the Illinois judicial system and to propose effective solutions to the problems identified.
