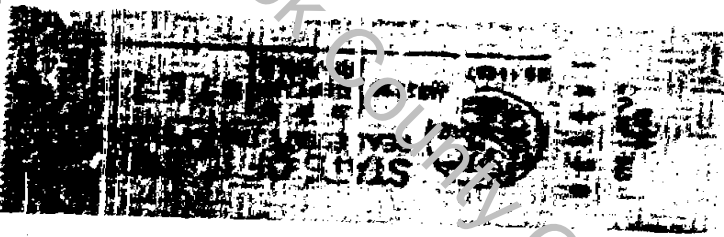

## LEGAL DESCRIPTION

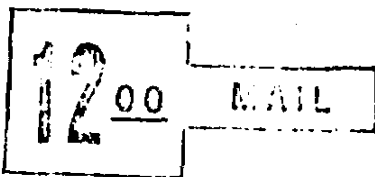
