That part of the NW $\frac{1}{4}$  of Section 18, T41N, R13, East of the Third Principal Meridian, described as: Beginning at a point on the East line of Harlem Avenue, said point being 225.1 feet South of the North line of said Section 18 and 50 feet East of the West line of said Section 18, and running thence North along said East line of Harlem Avenue a distance of 141.8 feet, more or less, to the South line of Golf Road; thence East along the South line of Golf Road a distance of 140 feet; thence South along a line parallel to the East line of Harlem Avenue, a distance of 141.7 feet to a point 150 feet East of the West line of said Section 18; thence West along a line parallel to the South line of Golf Road a distance of 140 feet, more or less, to the point of beginning.
