herein contained and for other good and valuable consideration, the receipt
whereof is hereby acknowledged, Trust No. 106231 does hereby transfer the
exclusive use of parking spaces 39 and 40 to Unit No. D-2.

THE PERCENTAGE INTEREST in the common elements of Units F-1 and
D-2 shall not be effected as a result of this Amendment.

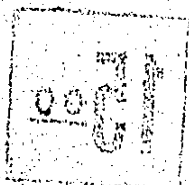

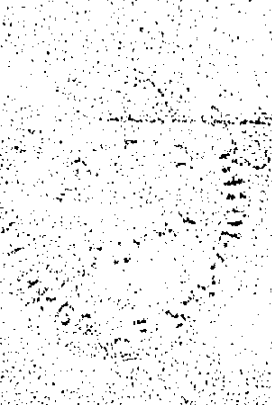

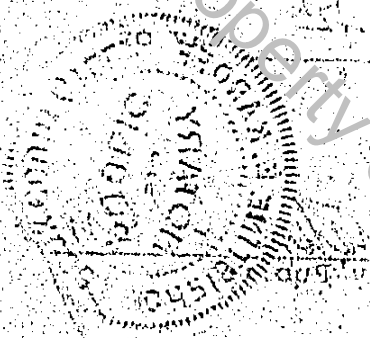
