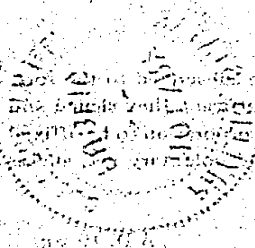
Unit 3-3 in Covington Manor Condominium as delineated on a survey of the following described real estate:
