Unit 9-6 in Covington Manor Condominium as delineated on a survey of the following described real estate:

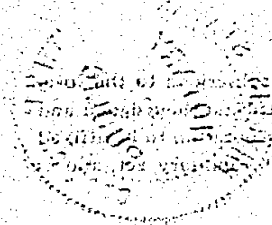
