THIS INDENTURE made February 11, 19 86, between

THAT, WHEREAS the Mortgagors are justly indebted to the legal holder or holders of the Installment Note herein-after described; said legal holder or holders being herein referred to as Holders of this Note, in the principal sum of

evidenced by one certain Installment Note of the Mortgagors of even date herewith, made payable to BEARER

and delivered, in and by which said Note the Mortgagors promise to pay the said principal sum and interest on the balance of principal remaining from time to time unpaid at the rate of Base+2 floating per cent per annum in installments as follows: Two Thousand eighty three and 33/000ths

Dollars on the first day of March 19 86 and Two Thousand Eighty Three and 33/000ths


Dollars on the first day of each month thereafter until said note is fully paid except the final payment of principal and interest, if not sooner paid, shall be due on the 1st day of February, 1988. All such payments on account of the indebtedness evidenced by said note to be first applied to interest on the unpaid principal balance and the remainder to principal; provided that the principal of each installment unless paid when due shall bear interest at the rate of maximum allowed by law per annum, and all of said principal and interest being made payable at such banking house or trust company in Oak Lawn Illinois as the holders of the note may, from time to time, in writing appoint, and in absence of such appointment, then at the office of Heritage

Bank of Oak Lawn in said City.
