Lot 7 (except North 49 feet thereof) and North Half of Lot 6 in Block 5 in Town of Dunton (now Arlington Heights), being a Subdivision of the West Half of the Southwest Quarter of Section 29, Township 42 North, Range 11, East of the Third Principal Meridian.

and in connection therewith and as part thereof, states as follows:  
That on and prior to 01/31/85, Loretta S. Bauer, 50% Int.; Suzanne K. Bauer, 25% Int.; Burton C. Bauer, Jr. and Carol K. Bauer, 25% Int. (J) was/were the owner(s) of the legally described property which is also commonly known as 409 N EVERGREEN Arlington Heights, Illinois,

and received and benefited from water service from the Village of Arlington Heights, and continued to receive benefit through the use of said water through 10/31/85 and incurred a total charge of \$122.50 from the Village of Arlington Heights, which became due and owing on 12/01/85 by virtue account statements rendered on or before said date; and twenty-one (21) days after said due and owing date, a penalty in an amount equal to ten percent (10%) of said amount was added as a penalty for failure to make prompt payment for a total sum of \$134.75 and twenty-one (21) days thereafter, to wit on 01/11/86 said account became delinquent, in accordance with the ordinance of the Village of Arlington Heights.

That there is still due, unpaid and owing to the Claimant the balance of \$134.75 for which, with costs of \$75.00 the Claimant claims a lien on said land and improvements in the total sum of \$209.75
