AMENDMENT TO ASSIGNMENT OF RENTS AND LEASES

This Agreement entered into this 30th day of December, 1985, by and between **MARTIN REINHEIMER** and **LUCY J. REINHEIMER** (hereinafter the "Assignor") and **EXCHANGE NATIONAL BANK OF CHICAGO**, a national banking association, (hereinafter the "Assignee");

WITNESSETH

That, WHEREAS, the Assignor executed and Assignment of Rents and Leases (hereinafter the "Assignment") covering a certain Parcel of Real Estate in Cook County, Illinois (which Parcel is legally described in Exhibit "A" hereto) on October 1, 1985 to secure payment of a certain Revolving Mortgage Promissory Note of even date therewith executed by Martin Reinheimer; and

WHEREAS, said Assignment was recorded as Document No. 85228229 in the Office of the Cook County, Recorder of Deeds; and

WHEREAS, the Martin Reinheimer now wishes to extend the indebtedness represented by the Revolving Mortgage Promissory Note; and

WHEREAS, the Assignee is willing to agree to said extension, provided that the Assignor agrees to the terms and conditions set forth in this Agreement.

NOW, THEREFORE, in consideration of the foregoing it is agreed that the first paragraph appearing on Page One of the Assignment immediately following the word "WITNESSETH" is hereby deleted and the following inserted in lieu thereof:


"THAT WHEREAS, Martin Reinheimer has executed a certain Revolving Mortgage Promissory Note dated October 1, 1985 as extended by a certain Extension Note dated December 30, 1985 (the "Note") and is justly indebted thereunder to Assignee for money borrowed in the aggregate principal sum of ONE HUNDRED FIFTEEN THOUSAND and 00/100 Dollars (\$115,000.00) (the terms of which Note are hereby incorporated herein by reference) and secured by a certain Mortgage as modified upon certain property (herein called "said Property") in the county of Cook and State of Illinois, to-wit:"

All of the terms of the Assignment are hereby incorporated by reference herein and in all respects, the Assignment, except as hereby amended, shall remain in full force and effect. Assignor, by execution of this Agreement, hereby reaffirms, assumes and binds itself to all of the obligations, duties, rights, covenants, terms and conditions that are contained in the Assignment.


