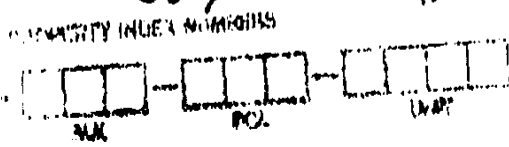

pending in said court and that the property affected by said cause is described as follows:

Parcel I: The North 50 feet of Lot "B" in Block 1 in the Catholic Bishop of Chicago Subdivision of Lot 13 in Bronson's Addition to Chicago in the East half of the Northeast Quarter of Section 4, Township 39 North, Range 14, East of the Third Principal Meridian in Cook County, Illinois.

Parcel II: That part of ground adjoining Parcel I therein on the West, North and East thereof, more particularly described as follows: BEGINNING at the Southwest corner of the North 50 feet of Lot "B" in Block 1 in the Catholic Bishop of Chicago Subdivision of Lot 13 in Bronson's Addition to Chicago, hereinafter referred to as Parcel I; thence West along the South line of Parcel I projected West a distance of 22 feet; thence North parallel to the West line of said Parcel I and along a line 22 feet West of said West line of Parcel I, a distance of 70 feet; thence East parallel to the North line of said Parcel I along a line 20 feet North of said North line of Parcel I a distance of 161 feet 11-1/4 inches, more or less, to a point 8 feet East and 20 feet North of the Northeast corner of said Parcel I; thence South parallel to the East line of said Parcel I, and along the center line of the alley being 8 feet East of said East line of said Parcel I, a distance of 70 feet, more or less, to a point in the center of said alley 8 feet East of the Southeast corner of said Parcel I; thence West 8 feet to the Southeast corner of said Parcel I; thence North along the East line of Parcel I, 50 feet; thence West along the North line of Parcel I, 31 feet 11-1/4 inches and thence South along the West line of Parcel I, 50 feet to the point of beginning, in Cook County, Illinois.

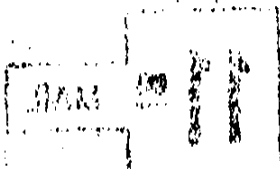
