ORDINANCE NO. 86- 2

AN ORDINANCE ACCEPTING THE DEDICATION OF CERTAIN STREETS IN THE VILLAGE OF INDIAN HEAD PARK, COOK COUNTY, ILLINOIS

WHEREAS, the President and Board of Trustees of the Village of Indian Head Park, after due investigation and consideration, have determined that it is to the best interest of the Village that the dedication of the streets hereinafter described be accepted and approved;

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Indian Head Park, Cook County, Illinois, that:

SECTION 1. The Plat of Dedication of Pembroke Drive, Stratford Court and Heatherwood Court in the Village of Indian Head Park, Cook County, Illinois, in the property described as:

Parts of Outlot 4 in Acacia Unit Three and Outlots 6 and 7 in Acacia Unit Four, all being subdivisions of part of the Northwest Quarter of Section 20, Township 38 North, Range 12 East of the Third Principal Meridian, in Cook County, Illinois,

as indicated by the words "Hereby Dedicated" on the Plat hereto attached, which Plat for greater certainty is hereby made a part of this Ordinance, be and the same is hereby approved.

SECTION 2. A certified copy of this Ordinance with a Plat of the streets to be dedicated, together with additional copies required for recording, shall be recorded by the Village Clerk in the office of the Recorder of Deeds of Cook County, Illinois.

SECTION 3. This Ordinance, after its passage and approval, shall take effect and be in full force when a copy thereof, together with a Plat, properly executed and acknowledged, showing the dedication provided for herein, shall be filed for record in the office of the Recorder of Deeds of Cook County, Illinois.

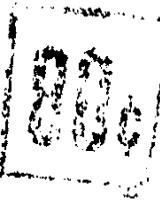

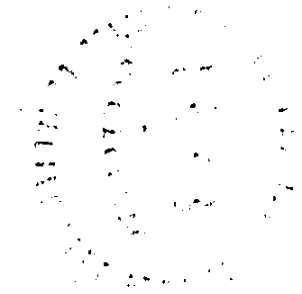
