THAT

of the County of Cook and State of Illinois, for and in consideration of one dollar, and for other good and valuable considerations, the receipt whereof is hereby acknowledged, do hereby promise, release, convey and quit-claim unto Omni House Youth Services Bureau of Wheeling Buffalo Grove, Prospect Heights an Illinois not-for-profit corporation, heirs, legal representatives and assigns, all the right, title, interest, claim, or demand whatsoever they may have acquired in, through, or by a certain mortgage, bearing date the 2nd day of June, 1975, and recorded in the Recorder's Office of Cook County, in the State of Illinois, in Book of page at Document Number 2342655, to the premises therein described, situated in the County of Cook, State of Illinois, as follows, to wit:

That part of Lot A in Willie's Consolidation of Land in Section 1, 2, 11 and 12 in Township 42 North, Range 11, East of the Third Principal Meridian, in Cook County, Illinois, described as follows: Commencing at a point in the center of Dundee Road that is 1864 feet, South 38 degrees 20' West, of a stone in the center of Dundee Road and Milwaukee Road; thence South 88 degrees 20' West, a distance of 192.03 feet; thence South 88 degrees 20' West, a distance of 275.62 feet to the center of Wolf Road; thence North 1 degree 38' 30" West, along the center of said Wolf Road, a distance of 192.00 feet to a point 324.45 feet South 1 degree 38' 30" East of the Center of Dundee Road; thence North 88 degree 20' East, parallel with the center of Dundee Road, a distance of 278.40 feet to the point of beginning.


